This is a reminder that your dues for membership in the Northern California French Bulldog Club for 2008 are now due. Just a reminder; the Individual and Family Memberships have voting privileges. Individual Memberships have one [1] vote, Family Memberships have two [2] votes. However, if you elect to have a voting membership please be advised that you are expected to attend four [4] club meetings throughout the year. We also have a Junior Membership available for persons over the age of 8 years and under 18 years. This membership does not require annual dues payments but does require a membership application to be submitted in the name of the Junior who is applying. The Junior Membership does not carry voting privileges. We always appreciate our members taking an active interest in club matters so your participation is encouraged regardless of the type of membership you do choose. And we welcome any ideas you might have for club events.

Because the current dues were the original amount as set forth when the club was initiated, they no longer covered the cost of printing and mailing the club newsletter let alone other notifications that are sent throughout the year. The Board of Directors voted to present to the general membership, for their consideration, the suggestion there be a dues increase. This was done at the last club meeting on October 21<sup>st</sup> and the membership voted unanimously to raise the dues for individual memberships to \$20, Associate Memberships will be \$20 and family memberships will be \$25. Junior Memberships will remain at no cost. This increase will begin with the dues for 2008 and is reflected in this letter. We sincerely hope you understand that given the increase in postage alone this was a necessary decision.
